Empowering Healthy Women Conference Set for April

When it comes to the life issues – abortion, euthanasia, stem cell research - there's a one-sided focus out there. Delaware Nurses for Life, in conjunction with Delaware Right to Life and the Delaware ProLife Coalition, plans to shine a light on solid, science-based research when they host the first annual women's health conference on April 2, 2011 at the University of Delaware's Clayton Hall.

Following a panel discussion format, the conference will feature several health care professionals who will address issues long ignored by the mainstream media. According to organizer Bess McAneny, president of Nurses for Life, "They will be covering many issues where truth has been obscured because of political correctness, such as abortion links to cancer, infant mor-

tality, premature birth, black genocide, and post-abortion trauma," she said, adding that "the general public and even medical public aren't aware of the science so they buy into the media hype furthered by population controllers."

In addition to the above topics, the conference will also present information on the link between national health care "death panels" and euthanasia, as well as updates on stem cell research and vaccines. Invited speakers include nurses Kathy Hopkins, Mildred Lomabardi, and Kathy Arnold, as well as representatives from the Couple to Couple League, a natural family planning movement. The panel discussions will take place from 9 a.m. – 2 p.m. and light refreshments will be available.

"Informed consent is the key factor here – women aren't being informed about these links; people at the end of life when they sign advance directives aren't getting the full information about what that entails," says McAneny. In addition, national organizations such as the American Cancer Society, American Nurses Association, American Congress of Obstetricians and Gynecologists, and the National Health Association keep this information at bay.

McAneny, a retired nurse, has first-hand experience with how the existing health care system rejects scientific evi-

dence that doesn't advance its own agenda. "When I went down to the Infant Mortality Task Force (a Delaware health initiative) and presented research on the link of abortion to premature birth and infant mortality, my segment was the only one not in the final report," she said.

"Our goal is to arm people to be able to ask questions – regardless of where you stand on the issue you still need to KNOW, have informed consent," says McAneny, who urges women, parents, and anyone concerned about the future of women's health to attend.

Elkton, MD Site of Secret Late-Term Abortuary

A secret Elkton, Maryland abortuary became the latest to be exposed as a deadly, underhanded facility where money is the bottom line and illegal activities the norm.

Three “doctors” associated with the clinic – Steven Brigham, George Shepard, Jr., and Nicola Riley – have had their licenses revoked or suspended and the illegal scheme to perform late-term abortions by an unlicensed hack was shut down when a young woman suffered a botched abortion there last August. When authorities discovered that Stephen Brigham was transporting women from his clinic in Voorhees, New Jersey, where late term abortions are illegal, to Maryland, they raided his clinic in Elkton and discovered the bodies of 35 babies, some up to 36 weeks’ gestation, in a freezer there.

Local pro-life leaders are urging Cecil County State Attorney, Ellis Rollins, to bring criminal charges against Brigham, who has long had innumerable legal, medical, and ethical problems throughout his career as a baby killer.

Maryland law states that if an unborn baby is past viability and the baby’s life is taken in an illegal act, the perpetrator can be prosecuted for murder or manslaughter. Medical records indicated that many of the babies discovered there were well past viability.

34 of the bodies were ultimately released to Fr. Joseph Piekarski of Immaculate Conception parish and buried in their cemetery in Elkton.


Betty McFann Billboard Memorial Fund
